03/03/2025 - Technician: 053 ANDREW BILBREY - Work Performed: Appliance Sale - Removed 40 ft existing 1/2BI, replaced existing twin stage with 1st stage on tank, hung 2nd stage on post under deck connecting to existing yard line, ran 50 ft 3/4BI teeing 3 times, first tee feeds 10 ft sleeved copper to ball valve and quick disconnect for grill, second tee reduces to 12ft of 1/2BI running through deck connecting to ball valve quick disconnect to grill, third tee reduces to existing 1/2BI feeding to log set and range, 3/4BI terminates through garage wall to ball valve and flex line. Drained and removed old tanked WH plugging water lines, installed tankless WH in garage venting through wall. Water lines teed off of existing water lines in garage connecting to WH.
