08/06/2024 - Technician: 053 ANDREW BILBREY - Work Performed: Appliance Sale - Cut and removed existing 1/2in BI trunk line that was running to Furnace and replacing it with 20ft 3/4in BI teeing off twice in 1/2in, first tee was 15ft running up through floor with ball valve where new gas dryer was installed, the second tee ran 20ft then up through floor with ball valve where new range was installed with a 240 to 120V plug adapter. Old tanked WH was drained and removed, and tankless WH was installed with standard vent kit on far side of crawlspace running 60ft of 3/4 pex to it from where tanked WH once sat, 3/4in BI was extended from existing gas line to unit with ball valve. Safety check was then performed which passed leak test. Customer had to leave but is coming by shop to sign safety check.
